Kerry, WD4SIG/M worked hard in KY and TN running a great CW signal, giving out those counties that no one ever goes to unless they have to.

Had a long informative letter from Gene, W1TEE. Space won't allow the entire letter so will just hit the highlights. Gene, along

with most others who have ever run in Texas discovered that Texans like to brag about Texas, but hide their County Line signs. Now what kind of a mentally unbalanced highway official would do things like that? Rain, snow and sleet plagued Gene on his Take the Alamo single-handed Texas run in November. His weapons were a ICOM-735 to a Hustler mounted on the back bumper of his faithful 1976 Plymouth Duster that just turned over a mere 300,000 miles as he was leaving Red River County, TX. Gene says there will be no Alaska. or Hawaii effort until he has cleaned up the lower 48.

# Minutes Of The MARAC Monthly Meeting

The December meeting of MARAC was held on the 10th at the Holiday Inn East, St. Paul, Mn. President Don, WAOLKL, called the meeting to order at 8:52 AM. El Presidente requested that the minutes show that the meeting convened considerably before the appointed hour of 9:00 AM.

Also in attendance were WONNH, WAORJJ,

NOAKC, W9LHG, WOKMH, and WBOUPU.

John, W9LHG, presented the Treasurer's Report for the month of December. With a healthy checking account balance plus \$500 being transferred to the saving's account, WONNH made a motion to accept the Treasurer's report, seconded by NOAKC, passed.

Vern, WAORJJ, reviewed the November's Secretary report as printed in the ROADRUNNER. With no corrections forthcoming, W9LHG made a motion to accept the minutes as printed, seconded by NOAKC, passed. The Secretary also reported that as of 11/30/88, MARAC enjoys an active membership of approximately 820.

There was some general discussion of the cost and contents of the County Hunter information packet provided by MARAC. Jerry, WONNH, reported that expenses for the information packet run approximately \$40/month. The bulk of that expense is incurred for duplication costs. The Secretary reaffirmed the value of the information packet, with more than half of all applications for MARAC membership coming from the application form supplied with the packet. A committee composed of the Secretary and Treasurer will look at the feasibility of improving the information packet content.

President Don indicated that he is working with Bill, WOOWY, to obtain closure of the 1988 National Convention account, and expects that to happen soon.

Everyone present expressed their heartfelt sorrow, concern, and understanding to Jerry, WONNH, after the recent passing of his wife Carol.

With no additional business, WBOUPU made a motion to adjourn, seconded by NOAKC, passed. The next regular meeting will be held on January 14 and February 11 at the Holiday Inn East, St. Paul, MN.

#### NEW LOOK FOR MARAC CONTESTS

Over the past year many county hunters have expressed a desire to align the rules of the SSB and CW county hunters contests. While the basic idea behind the two contests is very similar, the mechanics of each contest differed. For example, each contest followed separate rules for categories of entries, report exchanges, and awards. In addition, the SSB contest has traditionally held the first part of May and the CW contest has been held in late July each year. Well...much of that is changing in 1989.

Attendees at the this year's Northwest Mini, input from individual county hunters, contesters, and those in attendance at Manchester suggested that standardizing the rules between the contests would resolve some of the confusion that arises out of the differing rules. Additionally, the MARAC Awards Custodian pointed out that timing of the contests were out of sync with the annual MARAC national convention. Putting all of this together, the 1989 MARAC SSB Contest will be announced soon with the following changes in rules and format:


- Dates: 8/9 April 1989
- Rest periods are eliminated
- Competition for awards will be limited to stations which operate only one transmitter at any one time
- Contacts operating under a net control will be invalid for contest scoring purposes
- The portable entry category will be reinstated
- Contest exchanges will now require a consecutive serial number and category of entry
- Scores of at least 50,000 points will be required for for awarding of plaques
- Mobiles will be eligible for awards based on state of operation as well as overall
- A check sheet will be required of entries with 100 or more counties worked

These changes arise out of the reconciliation of the SSB and CW contest rules and will be followed in the future for both contests.

The SSB contest was moved to April to allow the CW contest to be held in May----both moves in an effort to allow the awards to be personally presented to the winners at the MARAC national conventions.

Complete rules for each contest will be published in  $\underline{CQ}$ ,  $\underline{QST}$ , and in the  $\underline{County\ Line\ Road\ Runner}$ .

The contests create a lot of interest in county hunting among the general ham population and activates many needed counties. Please plan to participate in the 1989 MARAC county hunters contests. When the zero hour of the contest starts, every county in the United States become rare. If you have not entered one of the contests before, give it a try. They are your contests...and it's your fun that you will be missing.



FOR IMMEDIATE USE When completing the Last County Award Application blank, please mark the band as 75, 40, 20 etc. The entry on the computerized system uses band (not Frequency). Entering just the band will help me help you. Also the awards will be processed as SSB awards unless the application is clearly marked for EW or FM. The custodian will enter an award as CW if he knows the operators involved to be CW only operators but otherwise will make the award out for SSB operation. It would help if you would mark your applications with the mode.

Also, for the umpteenth time, the Last County award, Category 2 (The Last County for all USA Counties) has a fee of \$15. for the plaque. A separate certificate showing Category 2 for the Last county in the state will be issued as a part of this fee buthe fee is basically for the plaque. A separate \$1.50 fee and a separate Last County Award application blank are not required. just confuses the custodian and he gets plenty confused all the time enihow. So the last of all (which includes the last in a state) has a fee of \$15, and only requires one application blank. Mark your application as Category 2.

I am still working on a revision to the Last County Application form which will include the two items above but am not sure whe the new form will be available. Until then, continue to use the old one. I am currently running in excess of 4000 award applications per year so ask you help by ensuring that you use only the authorized form and trim it to the exact size required which is 8 1/2 X 3 1/2 inches. All applications are filed after processing and the filing cabinet that I am using is designed hold that size form and other sizes make it very difficult to file the application properly. Thanks a bunch for your help.

On a side note, if you haven't seen it, the 18th Edition of the County Hunters Handbook is printed and in distribution. It has 140 pages of the very latest updated information that should be a valuable operating asset to all County Hunters. If you would like one, contact me direct for the ordering information. When they are gone, they are gone.

As a result of polling the awards committee, there will be NO recommendation to the membership to divert from the USA-CA rules as was suggested we could do at the Manchester Mini.
